The Southwestern Society of Economists (SSE) announces its annual meeting in Hyatt Regency and Albuquerque Convention Center, 330 Tijeras NW, Albuquerque, New Mexico, USA, 87102, in association with the annual meeting of the Federation of Business Disciplines (FBD). We invite academicians, practitioners, undergraduate and graduate students to be involved in our dynamic organization by:

1. **Presenting** a paper on a topic of interest to both academicians and practitioners.
2. **Organizing** an invited paper session, invited panel or tutorial.
3. **Serving as a session chair and/or paper discussant.**
4. **Participating in Poster Sessions:** Please submit a 2-page abstract plus a draft of the final poster of the research. This venue is ideal for undergraduate, master and doctoral students.

***SSE does not require a submission fee. However, presenters and participants must register for the conference.***

5. **2018 McGraw-Hill/Irwin Distinguished Paper Award:** If you are submitting a complete paper please indicate whether you want this paper to be considered for the McGraw-Hill/Irwin Distinguished Paper Award.

**6. 2018 FBD Outstanding Educator Award:** Please nominate a colleague, current or former professor, or friend for the 2018 FBD Outstanding Educator Award. Nomination should be in the form of 2-3 page letter summarizing why does the individual deserve life time achievement award.

**SUBMISSION PROCEDURE FOR 2018 CONFERENCE:**

**Online Submission through EasyChair:** The SSE will accept online submissions through the EasyChair conference submission system. The following link will take you to the EasyChair submission site.

The submission process requires registration to create new EasyChair account and sign in as an author, prior to submission. You can also send the proposals to the Program Chair at the e-mail address listed below. Hard copy of the proposal can also be mailed to the University address below. Authors may submit full-length papers, research-in-progress papers, abstracts, or proposals for special panels and invited sessions through this system by the above-mentioned deadline. After initial screening by the Program chair, all submissions will be double-blind reviewed before acceptance letters are sent to the author(s).

***Paper submitted to the SSE conference must be an unpublished and original research and must not have been submitted to any other member associations of the Federation of Business Discipline.***

**CONFERENCE REGISTRATION:** Conference registration will open on December 1, 2017 through the FBD website at [www.fbdonline.org](http://www.fbdonline.org). Pre-conference registration will close on February 8, 2017. Late registrations require higher fees. The FBD registration fee allows attendance at all paper sessions, FBD coffee breaks, and reception.
